#### Basic guidelines for taking Mart / Shoppe

- 1. No GST registration is required for Mart and Shoppe if Business with turnover above the threshold limit of Rs. 40 lacs (Rs. 20 lacs for North Eastern States, J & K and Himachal Pradesh and Uttarakhand). Company would bill the retail invoice in the similar cases and the firm/individual can bill it further.
- 2. The Mart/Shoppe falls under compensation scheme whose turnover is less than 1.5 crore. In case of North East, Himachal Pradesh, J & K and Uttarakhand the limit is below 75 lacs. In compensation scheme the Mart/Shoppe has to file GSTR-4 Quarterly and GSTR 9A yearly.
- 3. Basic Area Requirement and design specification would be done as per company specification and as given in the brochure.
- **4.** Company would take maximum stock 3% of the expiry and damage and would settle quarterly. This would be settled MRP to MRP stock exchange.
- 5. In case of closure of the Mart/Shoppe, clear valid reason for closure will have to be mentioned. Company would take the stock back which is purchased in last 90 days. All the transportation & other charges, taxes/Gst would be beard by Mart/shoppe owner. Near expiry stock would not be taken back for more than 3% of the sales. Company would settle the account within 90 days after receiving the stock in good condition back in the company depot. Company would deduct the branding investment done during the starting of the franchise. Damaged goods will not be taken back.
- 6. Margin would be as per specified and the margin would be build up in the primary.
- 7. Mart/shoppy accepts the Terms & Conditions of the Company for opening /operating Yuva energy retails pvt ltd. which may change from time to time and the same will be accepted by the Mart/shoppy from the date they are announced by the Company.
- 8. All disputes are subject to Vadodara (Gujarat) jurisdiction only.
